



## MEMORANDUM OF UNDERSTANDING Between The University of Arizona and Delhi Public School Nacharam, Hyderabad

Through this Memorandum of Understanding ("MOU"), the Arizona Board of Regents for and on behalf of the University of Arizona (hereinafter "U of A"), located in Tucson, Arizona, U.S.A., and Delhi Public School Nacharam (hereinafter "DPS"), located in Hyderabad, Telangana, India aim to support the mission of each institution, particularly those related to enrollment of academically qualified students from DPS to the U of A.

The U of A and DPS each is a "Party"; collectively, they are the "Parties".

The Parties intend to establish a program to provide opportunities for students of DPS to participate in educational programs offered by the U of A as follows:

- Appoint a liaison to jointly plan for recruitment, selection, and admission of DPS students to the U of A; and evaluation of student performance and language proficiency.
- Regularly interact so that DPS students and staff are informed about the U of A's program
  offerings, admissions requirements, and necessary steps for enrollment.
- Create promotional and recruitment materials for and host events such as application workshops, themed information sessions, university fairs and other engagements.

This MOU is not intended to be a binding agreement between the Parties, but rather a statement of the intentions of the Parties to negotiate the terms and conditions of a formal agreement for mutual cooperation and activities in the future, including specific provisions for the ownership of intellectual property, as well as financial consideration. No confidential or export-controlled information shall be disclosed pursuant to this MOU.

This MOU is subject to cancellation pursuant to Arizona Revised Statutes § 38-511 regarding Conflict of Interest if any person significantly involved in negotiating, drafting, securing or obtaining this MOU for or on behalf of the University of Arizona becomes an employee in any capacity of the other Collaborating Institution or a consultant to the other Collaborating Institution with reference to the subject matter of this MOU while the MOU or any extension thereof is in effect.

This MOU will be in effect for five (5) years from the date it is fully executed. After this initial period, the Parties may re-examine this MOU and make any necessary adjustments based on a mutually agreed-to assessment of the collaboration. This Agreement may be terminated by either





Party, with or without cause, upon thirty (30) days written notice to the other at any time before the date of expiration. This MOU may be terminated immediately, in whole or in part, in the event that any participant collaborating under this MOU is included in any applicable restricted party screening list.

Neither Party shall use the name, logo, likeness, trademark, image, or other intellectual property of the other for advertising, marketing, endorsement, or any other purpose without the prior written consent of an authorized representative of the other Party concerning each such use.

This MOU may be signed in counterparts, which together will constitute one agreement. If this MOU is signed in counterparts, no signatory to this MOU will be bound until both Parties have duly executed, or caused to be duly executed, a counterpart of this MOU. Each Party may rely on facsimile or electronically transmitted signature pages as if such facsimile or electronically transmitted pages were originals.
