At any time during the validity of the quotation, no price variation due to escalation, inflation, fluctuation in exchange rates, or any other market factors shall be accepted by Balajee Arun Educational Society after it has received the quotation. At the time of award of contract or purchase order, Balajee Arun Educational Society reserves the right to vary (increase or decrease) the quantity of goods, by up to a maximum of 20% of the total offer, without any change in the unit price or other terms and conditions.

The supplier warrants that no employee of Balajee Arun Educational Society or other branches has received or will be offered by the supplier any direct or indirect benefit arising from this contract or the award thereof. The vendor agrees that breach of this provision is a breach of an essential term of this contract. If the supplier is unable to deliver the goods by the date stipulated in the purchase order, the supplier shall immediately consult with Purchase Dept. of Balajee Arun Educational Society to determine the most expeditious means for delivering the goods. Goods received will be inspected against the minimum specifications and compliance described.

DPS, Nacharam shall have a reasonable time after delivery of the goods to inspect them and to reject and refuse acceptance of goods not conforming to the specifications. Inspection prior to shipment does not relieve the supplier from any of its contractual obligations.
