The vendor agrees that breach of this provision is a breach of an essential term of this contract.

If the supplier is unable to deliver the goods by the date stipulated in the purchase order, the supplier shall immediately consult with Purchase Dept. of Balajee Arun Educational Society to determine the most expeditious means for delivering the goods.

Balajee Arun Educational Society shall have a reasonable time after delivery of the goods to inspect them and to reject and refuse acceptance of goods not conforming to the specifications. Inspection prior to shipment does not relieve the supplier from any of its contractual obligations.
